Bidders are required to follow the electronic bid submission procedure as specified in e-GP System Operating Guideline 2073 and User manuals issued by PPMO which are available in e-GP system.
- 8. Online bids shall be opened in the presence of Bidders' representatives who choose to attend at 1:00 Pm on 24/12/2019 at the office of "Bakaiya Rural Municipality, Hattisunde, Makawanpur". Online bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security amounting to a minimum as mentioned in table below which shall be valid for 30 days beyond the validity period of the bid. The scanned copy of bid security should be uploaded in the e-GP system during bid
- 9. If the Bidder wishes to submit Bid Security in the form of cash the Bidder has to deposit cash in the following account:
